Was ist Paychek Safeguard?

Eine lokale Schutzvorkehrung: Ihre Disziplinregeln werden beim Trading zu technischen Einschränkungen.

- Defines rules in the Windows software (Safeguard)
- The NinjaTrader addon applies / displays status in real time
- If a rule is breached → trading blocked (orders rejected when Blocking on)
- Runs locally (127.0.0.1) — the PC must remain on

Zwei Komponenten, eine lokale Verbindung

1. Windows software

Safeguard UI: rule plan, capital, engage discipline, licence. Local HTTP server.
2. NinjaTrader 8 addon

Discipline window: Connected, OK / BLOCKED, counters, Sync zones, Blocking on.
3. Real-time connection

127.0.0.1:8080 · shared secret.
Without Safeguard open, there is no safeguard.

Starts the local server + UI. The server remains active even if the UI is closed (STOP.bat to stop it).

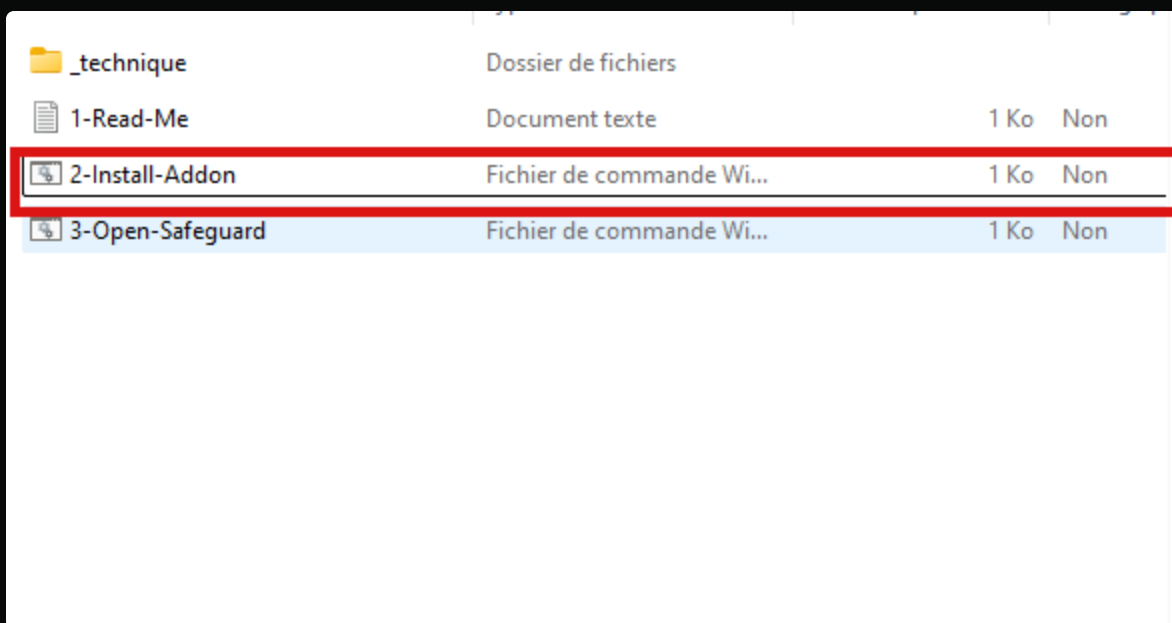
NT → New → Paychek Safeguard

Discipline window → Connected → activate PAYC licence → Engage discipline.

4

4-Uninstall-Addon.bat

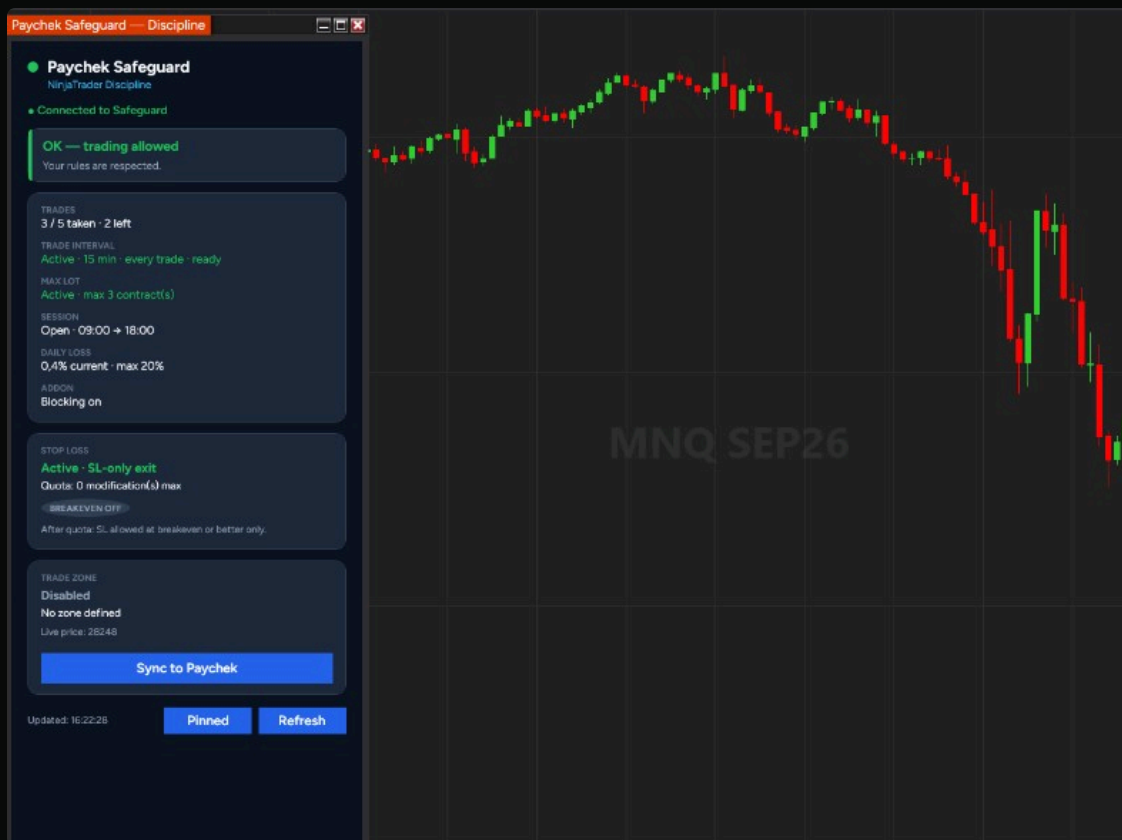

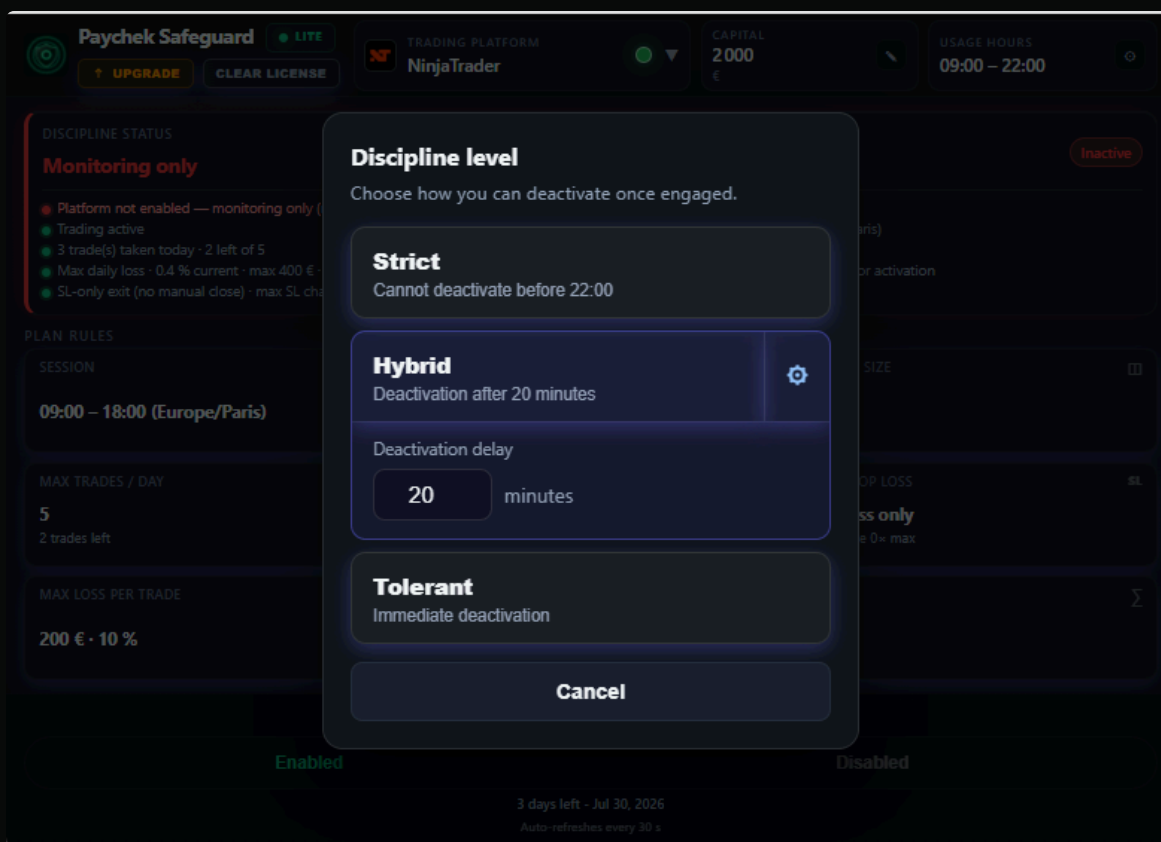
- **Connected to Safeguard** — active connection
- **OK / BLOCKED** — permitted or rule breached
- Live counters: trades, interval, lot size, session, daily loss
- **ADDON Blocking on** — non-compliant orders rejected
- **Sync to Paychek** — sends chart zones
- Pinned / Refresh



DISCIPLINE

Engage & levels

- **Strict** — cannot be disabled before the cut-off time (e.g. 22:00)
- **Hybrid** — can be disabled after a delay (e.g. 20 min)
- **Tolerant** — immediate disabling
- Enabled = active plan · Disabled = pause / monitoring

Sitzung

Trading hours (time zone, e.g. Europe/Paris).

Max trades / day

Maximum number of entries per day / session.

Max. Lotgröße size

Maximum contract / lot size.

Trade-Pause

Wait after a trade / after a loss.

Max. Verlust / Trade

Maximum risk per trade (€ and %).

Max. Tagesverlust

Maximum daily loss (€ and %).

Trade-Zone

Price zone on the chart; outside the zone = block.

Exit / SL

SL-only, amendment quotas, breakeven.

Capital / Nutzung

Reference capital + software usage window.

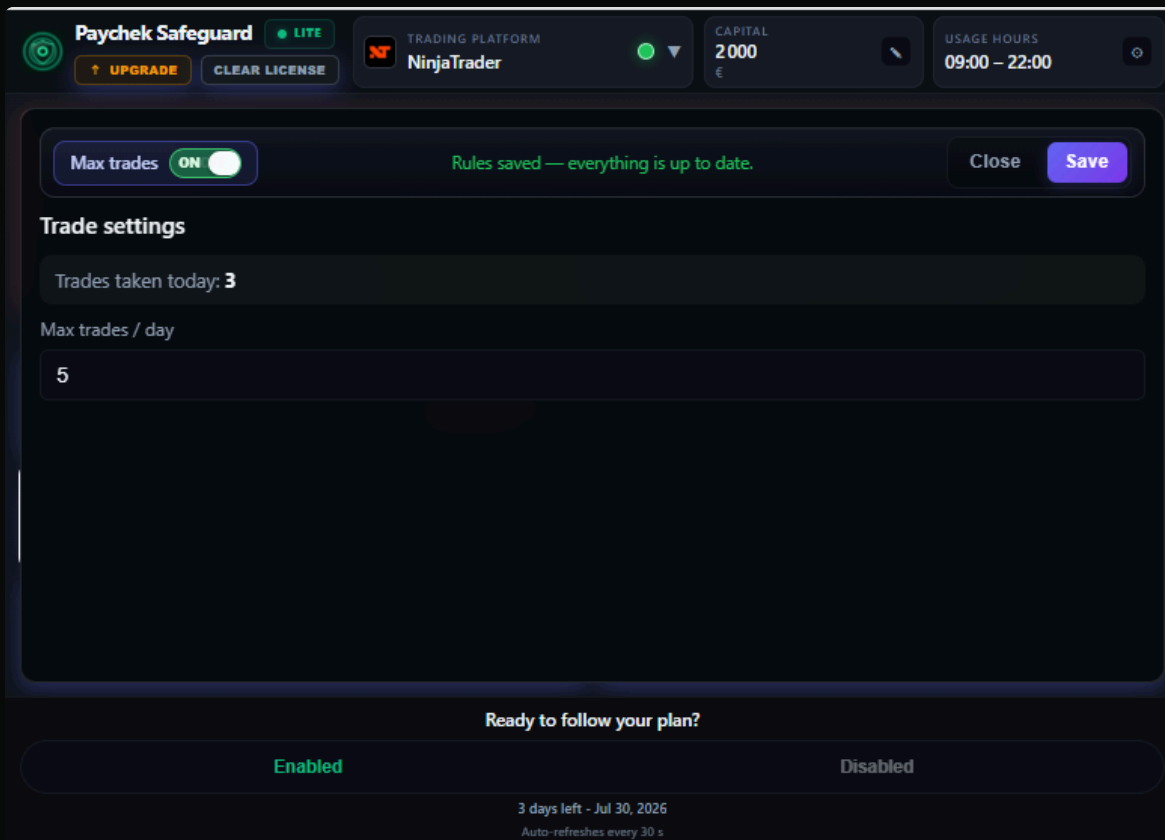
Trading-Zeitfenster

- Start time → end time (e.g. 09:00 → 18:00)
- 12-hour / 24-hour format
- Time zone (e.g. Europe/Paris)
- Outside session → trading blocked if Enabled

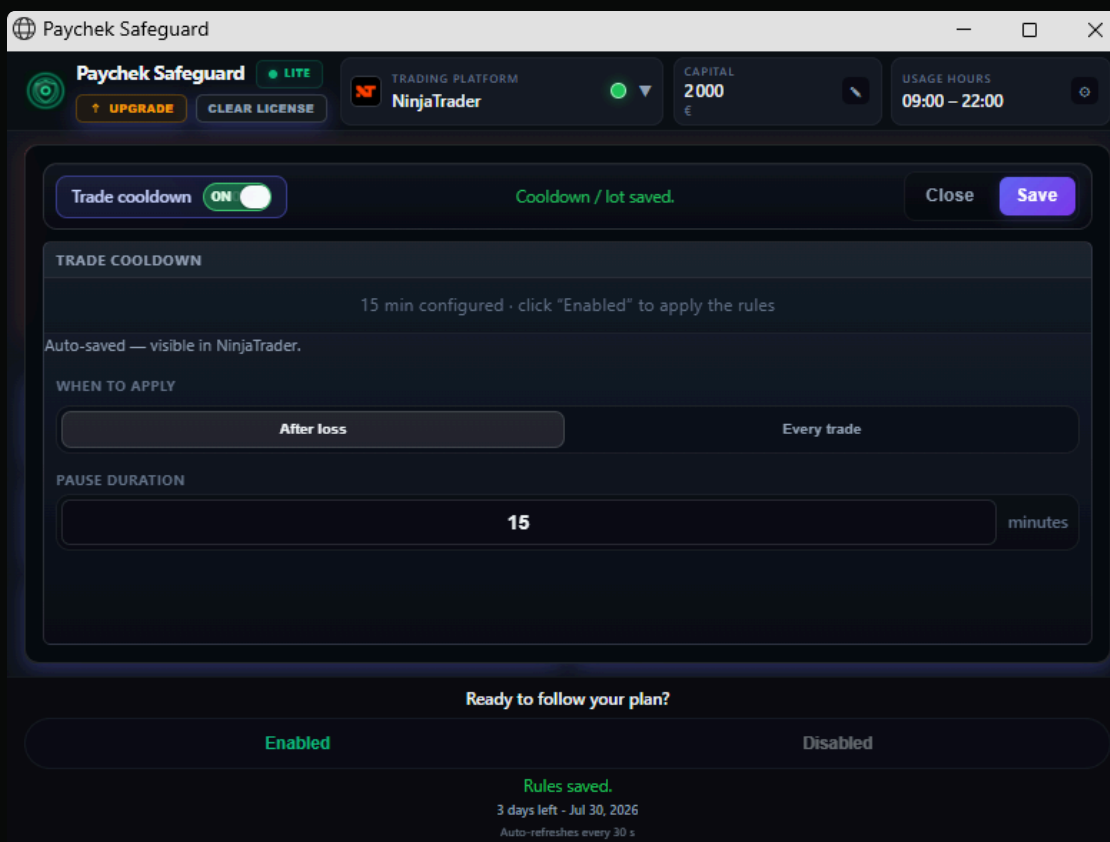

- With Ninja + Enabled: closes if floating loss exceeds the threshold

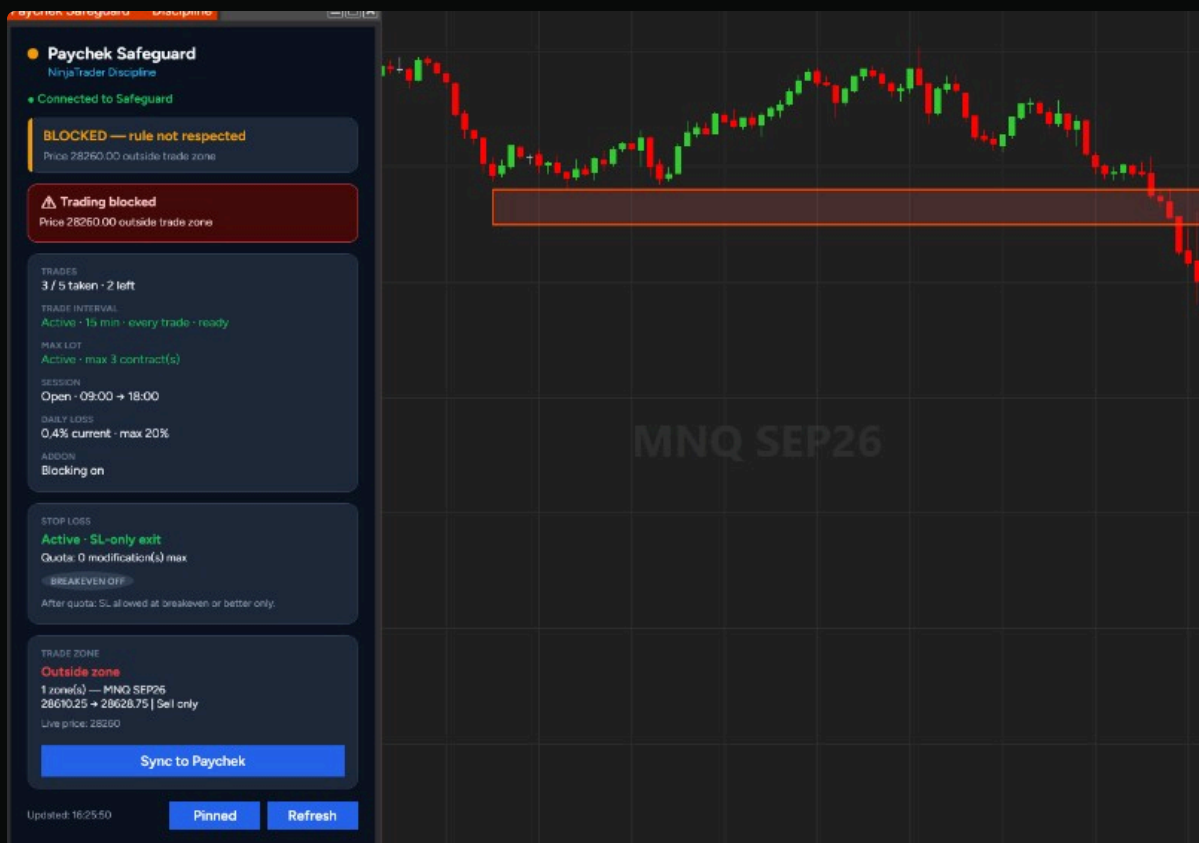

Preiszone im Chart

- Draw a Paychek zone on the NT chart
- **Sync to Paychek** to send it to the software
- Outside the zone → BLOCKED (price outside trade zone)
- Direction available (e.g. Sell only)
- Live price displayed in the addon



Synchronisierte Stop Losses

- **Quota** — number of SL amendments (0 = locked from the outset)
- **Breakeven** — after the quota: SL only at BE or better
- SL-only mode (no manual close, depending on configuration)
